

MEDICAL RELEASE, INDEMNITY AND HOLD HARMLESS AGREEMENT

The undersigned, being of lawful age, in consideration of being permitted in or about the backstage area (“Backstage”) for any reason whatsoever prior to, during or after the Bon Jovi concert, for the undersigned and the undersigned’s representatives, heirs, executors, administrators and next of kin, hereby **covenants not to sue, releases, waives and discharges** Bon Jovi (including without limitation the members of Bon Jovi and their family members), Bon Jovi Tours, Inc., the Jon Bon Jovi Fan Club, Inc., Backstage with Jon Bon Jovi, the promoter, the venue owner, Island Music Group, BANDMERCH, One Live Media and their respective affiliates, contractors, officers, employees and directors (collectively, “Releasees”) from all liability to the undersigned and the undersigned’s personal representatives, heirs, executors, administrators and next of kin **for all loss and damage, and any and every claim, demand or action, of every kind or nature, either in law or in equity, on account of injury, known or unknown, to the person or property, or resulting in the death of the undersigned, whether caused by negligence (including sole, contributory and gross negligence), strict liability or willful misconduct of Releasees or otherwise**, while the undersigned is on or near the Backstage.

The undersigned agrees to indemnify, hold harmless and defend Releasees and each of them from any loss, liability, damage or cost (including without limitation reasonable attorneys fees and expenses) that Releasees may incur in connection with the presence of the undersigned in or about the Backstage whether caused by negligence (including sole, contributory and gross negligence), strict liability or willful misconduct of Releasees or otherwise. The undersigned assumes full responsibility for, and risk of, bodily injury, death and property damage, whether due to the negligence (including sole, contributory and gross negligence), strict liability or willful misconduct of Releasees or otherwise, while the undersigned in or about the Backstage. The undersigned also releases all of the Releasees from any claim whatsoever on account of first aid, treatment or service rendered to the undersigned during or as a result of the undersigned’s presence in or about the Backstage.

The undersigned expressly agrees that this release, waiver and indemnity agreement is intended to be as broad and inclusive as permitted by applicable laws and that if any portion of the agreement is held invalid, it is agreed that the balance shall continue in full legal force and effect.

THE UNDERSIGNED REPRESENTS AND CERTIFIES THAT THE UNDERSIGNED IS OF LEGAL DRINKING AGE IN THE STATE/JURISDICTION OF THE CONCERT IF THE UNDERSIGNED IS OR INTENDS TO DRINK ALCOHOLIC BEVERAGES.

THE UNDERSIGNED HAS CAREFULLY READ THIS RELEASE, UNDERSTANDS THE CONTENTS OF THIS RELEASE AND SIGNS THIS RELEASE AS THE UNDERSIGNED’S OWN FREE ACT.
